YOUTH ACTIVITIES

Under the Direction of Okaloosa County Extension Office

1. AGE REQUIREMENTS:
CLOVERBUD DIVISION – Must have reached their 5th birthday and not passed their 8th birthday by September 1, 2017. (Receive participation ribbon in all exhibit categories.)
JUNIOR DIVISION - Must have reached their 8th birthday before and had not passed their 11th birthday by September 1, 2017.
INTERMEDIATE – Must be 11 before and have not passed their 14th birthday by September 1, 2017.
SENIOR DIVISION - Must be 14 and have not passed their 18th birthday or graduated from high school by September 1, 2017.
2. PRE-REGISTRATION - is required and should be turned into the Okaloosa County 4-H Office 3098 Airport Rd. Crestview, FL 32539 by **4:30PM on Friday, September 15th, 2017.**
3. ARTICLES ENTERED MUST FOLLOW GUIDELINES ESTABLISHED. Items must have been made by youth in last year (since September 2016).
4. REMOVAL OF 4-H LIVESTOCK SHOW EXHIBITS MUST BE APPROVED BY THE FAIR EVENT COORDINATOR. **Removal of exhibits without approval may cause forfeiture of premium money, and/or other awards.**
5. REMOVAL OF ITEMS FROM FAIR shall be done Saturday, September 30, 2017, after 10:00PM, or Sunday, October 1, 2016, from 10:00AM-2:00PM. **There will be no staff at the fairgrounds after 2:00PM. Therefore, you must have everything out. Removal of items before this time will cause forfeiture of premium money and/or other awards.**
6. ALL REASONABLE CARE will be taken of exhibits; however the UF IFAS Extension Okaloosa County Office or the Fair Association are NOT liable for damage, breakage, theft, etc.
7. UNSUITABLE EXHIBITS or exhibits of poor quality may be refused.

4-H CLUB DEPARTMENT

PROJECT EXHIBITS

This department is open to all bona fide Okaloosa County 4-H members only. Each 4-H member may enter up to 3 exhibits in each project area he/she is interested in. Items must have been made by 4-H'ers in the past year (since September 1, 2017).

A 4-H project exhibit can be one or more items made in a 4-H project. It can also be a tabletop exhibit consisting of poster, handouts, tri-fold etc. to depict what a 4-H'er is doing in a project. **NO LIVE EXHIBITS**. Project areas are listed below. 4-H'ers are encouraged to develop individual ideas for project exhibits, using the project book as a guide.

4-H PROJECT EXHIBIT

PROJECT EXHIBITS MUST BE NO LARGER THAN 18" WIDE BY 18" TALL BY 18" DEEP. EXHIBITS THAT DO NOT FOLLOW SIZE LIMITATIONS WILL BE REFUSED. **NO LIVE EXHIBITS WILL BE ACCEPTED.**

All judging will be done by the Danish System. Each project display will be presented a ribbon and premium. There will be Special Merit Awards for 4-H exhibits that demonstrate especially outstanding efforts and excellent quality. However, no more than 5 of these awards will be available. Decisions of the judges will be final.

Participants may enter up to 3 entries in the same category with a maximum of 20 entries in all exhibit categories.

SCORECARD

1. Quality of workmanship and appearance of finished project display; proper size - 40 points
2. Neatness - 15 points
3. Draws emphasis to what has been learned in project, i.e. clothing construction... submit a garment appropriate for project level skills - 20 points
4. Appropriateness of display in relation to project area, i.e. a box of mounted seashells for Marine Science. Display would be considered inappropriate until seashells are properly categorized, labeled, and shown according to the project manual - 25 points

CATEGORIES - 4-H EXHIBITS

1. Civic and Leadership Development

- A. Includes all exhibits related to citizenship, community service programs, and leadership.

2. Workforce Preparation and Career Development

- A. Includes all exhibits related to career exploration, preparing for a career, and entrepreneurship.

3. Clothing and Textiles

- A. Includes all exhibits related to clothing design, selection, buying, care, construction, textiles, accessories, personal appearance, and grooming.

4. Sewing/Crocheting/Weaving

- A. Includes all exhibits that have been sewn, crocheted, or woven by the youth.

5. Consumer Education, Money Management, and Home Management

- A. Includes all exhibits related to comparison shopping, sales approaches, advertising, consumer rights and responsibilities, labeling, credit, money management, banking, investment savings, and time management.

6. Earth Sciences

- A. Includes all exhibits in the areas of energy, earth science, astronomy, water quality/conservation, natural resources conservation and quality, soil science, geology, and weather.

7. Food and Nutrition

- A. Must not require refrigeration.
- B. Recipe must be included on 3" X 5" card.
- C. All entries must have the entrant's name, county, and 4-H club on the bottom of the plate or pan.
- D. Foods will be judged on appearance, texture, and flavor.
- E. Quantity required: whole cake, whole pie, 1 dz. cookies, loaf bread, 1 dz. biscuits, 1 dz. muffins.
- F. All entries must be made from scratch. No purchased crusts, mixes, or icings.
- G. All baked goods should be on or in a disposable container.
- H. Items submitted must be of sufficient quantity for judging and display.

8. Food Science and Safety

- A. Includes exhibits regarding food safety topics and food science, such as vacuum packaging, food irradiation, pesticides, food additives and biotechnology in foods.
- B. Food Preservation Exhibit
 - 1) Must be packaged in standard canning jars.
 - 2) No rings should be left on jars.
 - 3) Recipe procedure must be included on 3" X 5" card.
 - 4) Jar must be labeled with contents.
 - 5) Pickles, preserves, jams, jellies, fruits, vegetables and meats may be entered.

9. Natural Resources

- A. Includes all exhibits in the areas of forestry, marine and aquatic science, wildlife ecology, entomology, shooting sports, archery and riflery, and sport fishing.

10. Health and Safety

- A. Includes all exhibits related to general health education (i.e. coping with stress, first aid, substance abuse, self-help skills, physical fitness, dental care, healthy lifestyles, sex education, immunizations, and prevention of disease). Also includes all presentations dealing with accidental safety hazards including demonstrations in disaster preparedness or home environmental health (i.e. mold, radon or other hazards).

11. Horse

- A. Includes all exhibits pertaining to horses and horsemanship.

12. Animal Sciences

A. Animal Industry

1.) Includes all exhibits related to beef and dairy cattle, swine, layer, broilers, turkeys, rabbits, meat and dairy goats, quail, duck, geese and ratite. Exhibits can include systems relating to genetic selection, feeding management, health management, reproductive management and marketing. Systems also relating to converting or utilizing live animals to create food products such as milk, eggs, and meat. No equine related topics will be accepted in the category.

B. Small Animal and Pets

1.) Includes all presentations related to dogs, cats, rabbits, rodent pets, and other pets, including pet facilitated therapy in nursing homes, etc.

13. Human Development

- A. Includes all exhibits related to human growth, development, lifespan, personality and character development, and other interpersonal relations.

14. Leisure Crafts/Arts/Recreational Hobby

- A. Includes all exhibits of music, art, crafts, wood working and metal.

15. Mechanical, Electronic Science, Petroleum Power, and Small Engines

- A. Includes all exhibits related to general engineering, bicycle maintenance and mechanical operations, automotive, electronics, aerospace/aviation, and computers. Also, all exhibits related to use and conservation of petroleum-based fuels and the selection, care, and operation of small engines.

16. Communication and Media Arts

- A. Includes exhibits on the "topic" of public speaking, American Sign Language and other forms of communication. All phases of photography, graphic arts, computer graphics, video and other current technologies used in communication media.

17. Plant Connections

- A. Includes all exhibits relating to production and marketing of fruits, vegetables, flowers, turf, ornamental, field crops and forage, landscaping, green houses, propagation soils, hanging baskets, bulbs, citrus and harvesting or processing crops.
- B. Floral Arranging
 - 1) Includes any flower or plant arrangement made by the exhibitor.
- C. Gardening Project
 - 1) Harvested fruits and vegetables.
 - 2) Each entry is to be composed of several items arranged in an attractive display; unusual or large specimens may be entered singly.
- D. Ornamental Project
 - 1) Specimens must be owned by member and been in his/her possession for at least three months.
 - 2) Plants and flowers must be labeled with common and botanical name.
 - 3) All plants must be in good condition. Containers should be covered for attractive display.

18. Waste Management

- A. Includes exhibits relating to the management of solid and hazardous waste such as reducing, reusing, recycling, litter control and composting as a recycling/waste management process.

19. Photo Scrapbooking

- A. Youth can exhibit up to six (6) scrapbooking pages as one (1) exhibit.

4-H CLUB BOOTHS

CLUB BOOTH EXHIBITS ARE OPEN TO OKALOOSA COUNTY CLUBS ONLY

The purpose of the club booths is to depict a part of 4-H to non-4-H'ers and to the general public. **It must be in place NO LATER than Monday, September 25, 2017, at 8:00 p.m.** Each club will receive \$100.00 to help offset costs of exhibits.

SIZE: The 4-H booth will be approximately 10' wide and 8' deep with a partial divider between booths. Each of the booth's dimensions varies, and measuring is recommended.

5. Has pleasing appearance. Booth appropriately, conservatively and neatly decorated - 20 points

GENERAL RULES AND REGULATIONS FOR LIVESTOCK EXHIBITORS

All exhibitors are cautioned to read carefully the following rules and regulations, as they will be enforced strictly, with no deviation.

Administration of Rules and Regulations

The Northwest Florida Fair Association and the Okaloosa Extension Service reserve the final and absolute right to interpret these rules and regulations and to arbitrarily settle and determine all matters, questions, and differences in regards there to, or otherwise arising out of or connected with or incident to the Show, and right to amend or add to these rules as its judgment may determine. An exhibitor who violates any of the following rules will forfeit all privileges and premiums and be subject to such penalty as the Northwest Florida Fair may order.

Statement of Liability

1. All livestock exhibits will be under the direction of the Northwest Florida Fair Association and the Okaloosa Extension Service, but the Northwest Florida Fair Association, University of Florida, Okaloosa Extension Service, its employees and volunteers, and the Okaloosa Board of County Commissioners, will in no case be responsible for any loss or damage that may occur. Each exhibitor will be solely responsible for any consequential or other loss, injury or damage done to, or occasioned by, or arising from, any animal or article exhibited by him/her and for its description as given in the catalog, and shall indemnify the Northwest Florida Fair Association, University of Florida, Okaloosa Extension Service, its employees and volunteers, and Okaloosa Board of County Commissioners, against all legal or other proceedings in regard there to, as well as damage or injury to any other person or property, caused by the exhibitor, or any of the animals exhibited by him/her, or arising out of, or in any way connected with such exhibition of any of the animals so exhibited.
2. The Fair Management and Okaloosa Extension Service reserves the right to remove from the grounds any exhibit, animal, or fowl that may be falsely entered or may be deemed unsuitable or objectionable.
3. Each exhibitor (and exhibitor's parent or legal guardian) must sign the statement acknowledging that he/she understands and will abide by the liability requirements and rules and regulations of the Northwest Florida Fair and Okaloosa Extension Service. If the exhibitor does not sign this statement his/her application for entry will not be accepted.
4. Exhibitors must be clean and neat and dressed in long pants or skirt with solid white dress shirt or blouse. The 4-H Emblem must be visible on the shirt. Closed toe shoes are required. Showmanship is based on grooming and training of the animal, and the appearance and behavior of the exhibitor.
5. **All Exhibitors are responsible for hosting the 4-H Barn during the fair week.**

PURPOSE

1. To use the poultry project as a tool in the total development of youth in 4-H. This is especially adapted to rural non-farm and urban situations.
2. To provide a learning experience in livestock production.
3. To develop an appreciation of livestock among 4-H youth who may not be able to handle other types of large animal projects.

RULES AND REGULATIONS (PLEASE READ ALL)

An Official Certificate of Veterinary Inspection is required for all poultry, domestic birds and ratites for movement into Florida and for exhibition at the Northwest Florida Fair. All poultry entered for exhibition must originate from Pullorum-Typhoid clean flocks or hatcheries, as defined in rule 5C-16.008, Florida Administrative Code, or have a negative Pullorum-Typhoid test within 90 days prior to exhibition. However, poultry, domestic birds and ratites may be presented for exhibition without an Official Certification of Veterinary Inspection if inspected as provided in 5C-4.001(4) by a representative from the Florida Department of Agriculture, Division of Poultry. A State Veterinarian will be present at the Northwest Florida Fair site to inspect all poultry for disease and test for Pullorum-Typhoid before birds will be caged. Poultry showing any signs of disease, testing positive for Pullorum-Typhoid, or having external parasites will not be

1. Poultry must be owned or leased and in possession of the 4-H youth exhibitor at least 30 days prior to the date of the show.
2. Youth exhibitors must be bona fide 4-H members, and must have reached their 5th birthday by September 1 of the current year and not passed their 18th birthday or graduated from high school.
3. Poultry must be 6 months of age or older, and it is not recommended exhibiting birds older than 3 years of age depending on body condition and condition of plumage.
4. Each youth exhibitor may show up to five types of different chicken breeds, i.e. Plymouth Rocks, Polish, and Rhode Island Red. Each youth may show up to five types of different other poultry or game birds, i.e. ducks, geese, turkey, quail, pigeons.
5. Bring poultry entries to the Poultry Building located behind and to the left of the main fair buildings. Exhibitors must remain with their birds until veterinary examination has been conducted and birds are accepted for showing.
6. There is limited cage space in the Poultry Building, and 4-H exhibitors must pre-register listing how many breeds and the varieties they will be exhibiting. Due to the shortage of cage space, entries will be accepted on a first-come, first-serve basis.
7. Poultry will remain at the fairgrounds during the duration of the Fair. Poultry can be removed from the fair site Saturday, September 30, after 10:00PM or Sunday, October 1, between 10:00AM and 2:00PM. Removal prior to that time will cause forfeiture of premium money and/or other awards.
8. Feed and water for the poultry will be provided by the Okaloosa County 4-H.

9. All animals must be clean and well groomed.
10. Be sure to bring healthy birds to the fair as they will be examined by the State Veterinarian. Birds with external parasites, displaying runny eyes or noses, sneezing or displaying other indications of illness or disease will not be accepted for showing. Bring Showmanship chickens, if different from Exhibition chickens to be tested as well.
11. All poultry will be tested for negative Pullorum-Typhoid before being caged and accepted for showing.
12. Poultry will be judged by the standard of perfection as described in the "American Poultry Standard of Perfection" guidelines.
13. All decisions of the judge(s) will be final.
14. All Exhibitors are responsible for hosting the 4-H Barn during the fair week. Length of shift will be determined by the barn superintendent at fair-time. Length of shift depends on the number of exhibitors participating in the county fair.
15. Poultry Showmanship is open to any 4-H member with a poultry exhibit at the Northwest Florida Fair. The 4-H Emblem must be visible on the shirt or show coat. Basis for judging: showmanship is based on grooming and handling of the poultry, and the appearance and behavior of the exhibitor. Exhibitors are encouraged to present their poultry to the judge. Presentation of the poultry is up to the individual showman. Showmanship scores will be based on the criteria listed on the showmanship score sheet. The judge may or may not ask questions of the exhibitor at the close of the routine. The excellence of the poultry is not considered in scoring.

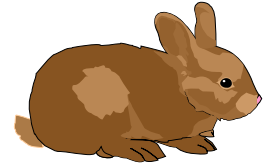
RULES AND REGULATIONS: (PLEASE READ ALL)

1. Youth exhibitors must be bona fide 4-H members who have reached their 5th birthday by September 1 of the current year and not passed their 18th birthday or graduated from high school.
2. Rabbits and cavy must be 8 weeks of age or older, well-groomed and clean.
3. No diseased or parasitic animals will be allowed to enter the show. All animals will be inspected.
4. The Fair will not be responsible for animals after 2:00PM Sunday, October 1, 2017. Animals can be removed Saturday, September 30, after 10:00PM or Sunday, October 1, 2015, 10:00AM-2:00PM
5. Maximum of three entries per youth in both divisions.
6. **All Exhibitors are responsible for hosting the 4-H Barn during the fair week.** Length of shift will be determined by the barn superintendent at fair-time. Length of shift depends on the number of exhibitors participating in the county fair.
7. Rabbit Showmanship is open to any 4-H member with a rabbit exhibit at the Northwest Florida Fair. The 4-H Emblem must be visible on the shirt or show coat. Basis for judging: showmanship is based on grooming and training of the rabbit, and the appearance and behavior of the exhibitor. Exhibitors are encouraged to present their rabbit to the judge. Showmanship scores will be based on the criteria listed on the showmanship score sheet. The judge may or may not ask questions of the exhibitor at the close of the routine. The excellence of the rabbit is not considered in scoring.

Market Meat Goat Show Judging: September 27, 2017, following the Dairy Goat Show

Goats or sheep presented for exhibition in Florida must be accompanied by an Official Certificate of Veterinary Inspection dated not more than 90 days prior to presentation. Goats must be accompanied by evidence of completion of the test requirements or certifications listed below.

Tuberculosis - All goats over six months of age must have a negative tuberculin test within 90 days prior to exhibition or must originate from an Accredited Tuberculosis-Free Herd, as defined in rule 5C- 7.016(1), Florida Administrative Code. When accredited, the accredited herd number must be recorded on the Official Certificate of Veterinary Inspection.

Brucellosis - All goats over six months of age must be negative to a brucellosis test within 90 days prior to exhibition or must originate from a Certified Brucellosis-Free Herd. A Certified Brucellosis-Free Goat Herd is a herd which meets the requirements for a Certified Brucellosis-Free Herd as set forth in 5C-6.002, Florida Administrative Code. When certified, the certified herd number must be recorded on the Official Certificate of Veterinary Inspection.

Specific Authority 5C-4.005 FS

Dairy Goat Rules and Regulations: (PLEASE READ ALL)

1. All Dairy goat shows will use ADGA rules. Official registration is required on show animals over 6 months of age.
2. All animals shall have a negative TB and Brucellosis test within 90 days and an official health certificate within 90 days.
3. Youth exhibitors must be bona fide 4-H members, and must have reached their 8th birthday by September 1 of the current year and not passed their 18th birthday or graduated from high school. Further, the exhibitor must reside in Okaloosa, Santa Rosa, or Walton counties.
4. Goats must have been owned or leased and in possession of youth exhibitor for 30 days prior to the date of the show.
5. All animals must be dehorned.
6. Exhibitors must be clean and neat and dressed in long pants or skirt with solid white dress shirt or blouse. The 4-H Emblem must be visible on the shirt. Closed toe shoes are required.

Meat Goat Rules and Regulations: (PLEASE READ ALL!)

1. Commercial goats will be weighed and tagged with a show number at 5:30 PM, September 27, 2017.
2. Youth exhibitors must be bona fide 4-H members, and must have reached their 8th birthday by September 1 of the current year and not passed their 18th birthday or graduated from high school.
3. All goats must be dehorned or have horns tipped.
4. All goats must have I.D. – scrapie tags where applicable.
5. Showmanship goats must be owned or leased by exhibitor for at least 30 days prior to show.
6. Exhibitors must be clean and neat and dressed in long pants or skirt with solid white dress shirt or blouse. The 4-H Emblem must be visible on the shirt. Closed toe shoes are required.

Beef Cattle Show Judging: Wednesday, September 27, 2017, immediately following goat show.

Purpose

1. To use the Beef Cattle Program as a tool in the total development and growth of youth in 4-H.
2. To provide a learning experience in production agriculture.
3. To provide youth a means to provide themselves financial security for their future.
4. To provide opportunities for demonstrating skills learned in selecting, producing, breeding, fitting and showing cattle.

All livestock for exhibition in Florida must be covered by an official health certificate issued by an accredited veterinarian. All health certificates for cattle must show detailed record of tests for each animal, giving breed, date of test, name and registry number, tattoo or ear tag number, and brand letters or numbers, and, if from a Tuberculosis Accredited herd or Brucellosis Certified herd, give accredited or certified herd number.

5C-4.02 CATTLE

Cattle consigned for exhibition must be covered by health certificate and must meet the following requirements:

(1) TUBERCULOSIS

A. Cattle may be entered for exhibition without tuberculin test provided they are identified on health certificates as originating in Accredited Tuberculosis Free herds or herds not under quarantine in Modified Accredited Tuberculosis Free areas.

B. Cattle which do not qualify under Subsection A above may enter for exhibition provided they were negative to tuberculin test within thirty (30) days of the date of exhibition. If any animals in the tested react, the remaining animals will be eligible for entry.

C. Tuberculin test is not required on steers entered in Fat Stock shows where only steers are shown.

(2) BRUCELLOSIS

A. Cattle may be entered for exhibition without brucellosis test provided they are identified on health certificate as originating in Certified Brucellosis- Free herds of Class Free areas.

B. Cattle from herds not under quarantine in Class A or Class B areas may be entered for exhibition if negative to brucellosis test with thirty days prior to entry into the fair or show. Cattle from such herds which are under 18 months of age, and official calf vaccinates under 24 months of age (Beef) and 20 months of age (Dairy) and which are not parturient or post parturient, are exempt from the test requirement.

C. Cattle from Class C areas which do not qualify under subsection A above may be entered for exhibition provided they originate from herds which are not under quarantine and which have been subjected to official brucellosis testing within (12) months prior to the date of the exhibition and the animals to be entered are:

1. Under 18 months of age; or
2. Official calf vaccinates over 20 months of age (Dairy), or 24 months of age (Beef) ;
or
3. Official calf vaccinates over 20 months of age (Dairy), or 24 months of age (Beef), and have had a negative official brucellosis test within thirty (30) days prior to the date of the exhibition and such test was not less than sixty (60) days after the qualifying herd test; or
4. Non-vaccinated cattle over 18 months of age and have had a negative official brucellosis test within thirty (30) days prior to the date of the exhibition and such test was not less than sixty (60) days after the qualifying herd test.

Rules and Regulations (PLEASE READ ALL)

1. Cattle arriving at times other than stated above must have prior approval of the Event Coordinator.
2. Early registration would be advisable since space is limited. Entries will be accepted on a first-come, first-serve basis.
3. All animals must be broken to lead and in suitable condition for showing in order to compete for premiums.
4. The Northwest Florida Fair will not be responsible for damage done by animals or injuries to animals. (Read General Rules and Regulations for Livestock Exhibitors)
5. Youth exhibitors must be bona fide 4-H members, and must have reached their 8th birthday by September 1 of the current year and not passed their 18th birthday or graduated from high school.
6. Heifers exhibited must be between the ages of 6-24 months.

7. Cattle may be purebred or crossbred.
8. Cattle will be shown in classes based on age.
9. Exhibitors may enter up to three (3) animals.
10. Exhibitors must own or lease an animal a minimum of 30 days prior to show.
11. Each animal must have a health certificate within 30 days and comply with Department of Agriculture regulations.

1. Youth exhibitors must be bona fide 4-H members and have reached their 5th birthday by September 1 of the current year and not passed their 18th birthday or graduated from high school.
2. Dogs must be owned by exhibitor or member of the immediate family.
3. Pure-bred and mixed breed dogs are welcomed as entries.
4. Animals must be leashed at all times - no dogs may be left unattended.
5. **Each owner/handler must be able to control their dog.**
6. **No electronic collars, no pinch/prong collars, no chain leashes allowed.**
7. **Each owner/handler is liable and responsible for his or her dog's behavior. Any dog misbehaving will be excluded from participation and may be required to leave the Fairgrounds.**
8. All dogs are required to have up-to-date shots. **Veterinarian proof of shots is required at show check-in.**
9. All dogs must be at least six (6) months of age.
10. No female dogs in season will be allowed to compete.
11. Each exhibitor is responsible for picking up after his or her dog.
12. **Exhibitors with dogs will be required to stay at area provided for the Dog Show ONLY. Dogs will not be allowed in carnival area or in fair buildings.**
13. Classes may be combined at the discretion of the 4-H Extension Agent (min of 3)
14. All decisions of the Judge(s) are final.

AGE REQUIREMENTS

Youth 5-7 years old - will receive a ribbon and \$10.00 premium for participation.

Youth 8-10 (Juniors), 11-13 (Intermediates), and 14-18 (Seniors) years old - will receive show premiums and a ribbon for first through sixth place awards.
