“Seeds to Table”

Three \$100 partial camp scholarships will be awarded to the top submissions. Entries are due June 22. Winners will be announced June 26. Scholarships will be applied directly to camp fee balance.

Description:

Create an image-based timeline of your favorite fruit, vegetable, or dairy item, accompanied with descriptive captions. In the timeline, follow the food item of your choice from seed or earliest form to the store, to consumption by the consumer.

Helpful tip: Pick a local, or Florida produced item at the store! Imagine that you are the item and all the places you have to go before you are brought home to your refrigerator.

For example:

Corn on the Cob: Journey from the home to summer picnic table!

Seed is planted in early May > (10-14 days) sprout breaks surface > (90-100 days) field corn is mature > Harvested in the fall with a grain combine > combine to truck to DC > Store > Cart > home (See example image).

Be creative!

Rules:

- Mixed media, illustrations, graphic design, original photography or other graphic art medium are all allowed.
- Final submission may be presented on any size paper/presentation board needed.
- Creations must be submitted at the UF/IFAS center in Wakulla no later than June 22nd, 2018
- All submissions must be accompanied by a complete signed entry form.

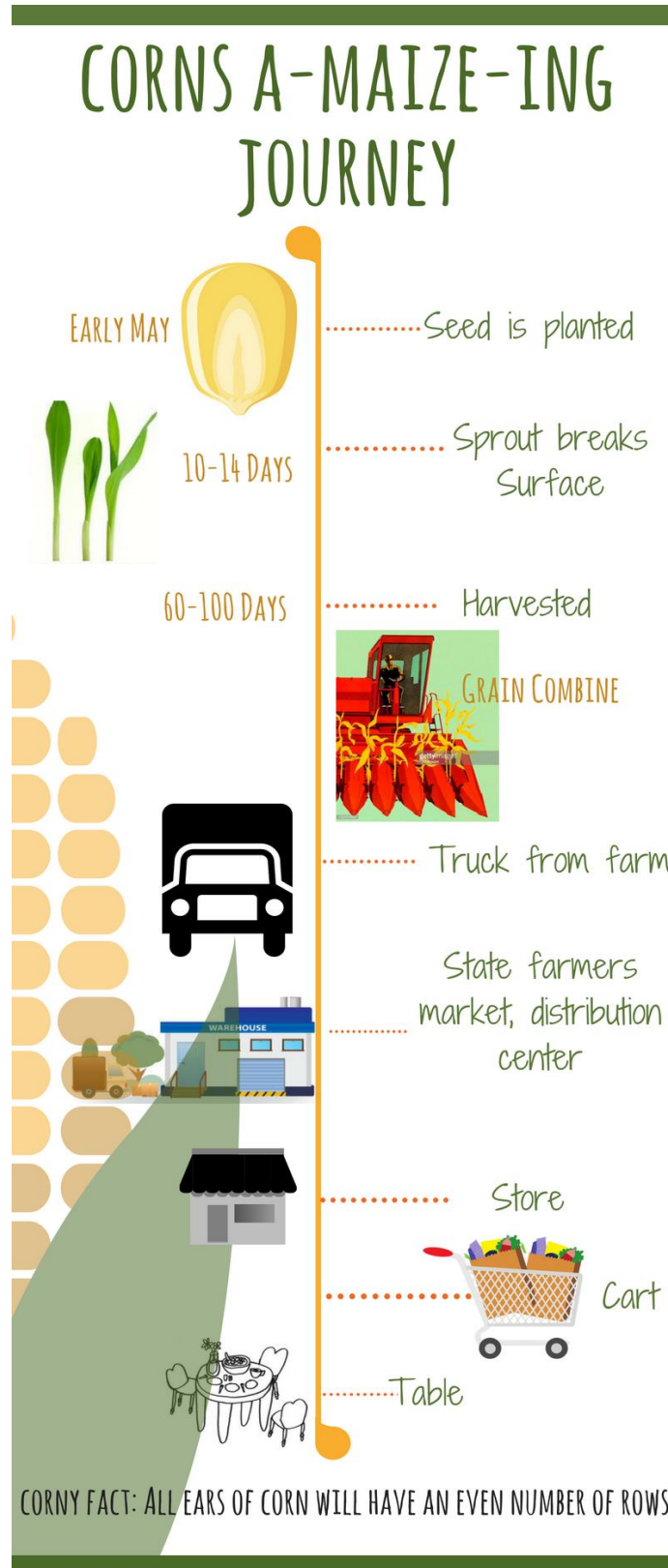
